1. I will abide by the mission, rules, regulations, policies, and programs of SARA while I am a volunteer.
2. If I stop being a volunteer for SARA for any reason, I will promptly return all of SARA's supplies, equipment, records, or any other items, in good and clean condition.
3. I assume the risks of being bitten, scratched, kicked, injured, or frightened by animals in connection with my volunteer work for SARA. SARA is not liable to me for any injuries, damages, liabilities, losses, judgments, costs, or expenses whatsoever, which I might suffer or sustain in connection with the performance of my volunteer activities for. I will indemnify, defend, and hold SARA harmless from and against any claims, lawsuits, injuries, damages, losses, costs, or expenses whatsoever, sustained by any companion animal or any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities for SARA, or my breach of SARA's rules, regulations, policies, and programs.
4. I understand and agree that SARA may refuse volunteer applications for any reason.
5. If I will be sheltering or providing foster care or boarding for any of SARA's animals in my home or business, I consent to SARA visiting my home or business from time to time to observe the animals and their environment.
6. I have accurately and truthfully completed this Volunteer Application and Agreement.
7. Any modifications to this Agreement must be in writing signed by both parties. This Agreement is binding upon SARA, me, and my respective heirs, successors, assigns, executors, and personal representatives.

PERMISSION AND RELEASE OF LIABILITY FOR VOLUNTEERS UNDER THE AGE OF 18

In consideration of SARA offering this volunteer opportunity, I agree to the following, intending it to be legally bound:

4. I understand and agree that SARA may refuse volunteer applications for any reason.
